- Class assemblies and performances. These will be shared on a private Google link only available to other parents
- Very occasionally in the media (newspapers, television etc) to mark a significant event

CONDITIONS OF USE

1. This form is valid for the period of time your child attends this school. Your consent will automatically expire after this time.
2. The school will not re-use any photographs or recordings after your child leaves this school without further consent being sought. Historic photographs will remain on the school website.
3. The school will not use the personal details or full names (which means first name and surname) of any child or adult in a photographic image, on video, on our website, in the school newsletter or in any of our other printed publications.
4. The school will not include personal email or postal addresses or telephone numbers on video, on our website, in our school newsletter or in other printed publications.
5. If we use photographs of individual pupils, we will not use the name of that child in any accompanying text or caption.
6. If we name a pupil in text, we will not use an individual photograph of that child to accompany the article.
7. We may include pictures of pupils and teachers that have been drawn by pupils. We may use group or class photographs or footage with very general labels, such as 'a science lesson'.
8. We will only use images of pupils who are suitably dressed.
9. Websites and social media platforms can be viewed throughout the world and not just in the United Kingdom, where UK law applies.

Notes on use of images by the media

If you give permission for a child's image to be used by the media then you should be aware that:

- The media will want to use any printed or broadcast media pictures that they take alongside the relevant story
- It is likely that they will wish to publish the child's name, age and the school name in the caption for the picture (possible exceptions to this are large group or team photographs)
- It is possible that the newspaper will re-publish the story on their website, or distribute it more widely to other newspapers or media organisations.
